## Available Courses

**LEVEL I** | Course fees are \$716.94 per person for six months of access.

Our Level I course gives learners a strong foundation in open-source intelligence gathering, enabling them to conduct effective, credible and defensible research and preparing them for future OSINT training.

Course modules include:

- Introduction: A brief history of the internet and how it works, as well as the intelligence lifecycle and key OSINT concepts
- Proper Sourcing and Reporting: Best practices for collecting information in a defensible manner
- Effective Search: Using search engines for investigative research
- Image and Video Research: Extracting and analyzing video and image evidence
- Introduction to Public Records and Publicly Available Information: Using public records and resources for information gathering

- Social Network Research: Collecting and analyzing social media data
- Virtual Footprints: Understanding anonymity and privacy and protecting yourself online
- Website Profiling: Collecting data from websites
- Online Data Assessment: Distinguishing fact from fiction online
- Mapping and Geographical Information
  Systems: Harnessing current and historical mapping information
- Working with Mobile Apps: Conducting research in mobile phone applications

**LEVEL II** | Course fees are \$775.16 per person for six months of access.

Building on previous OSINT training, our Level II course teaches advanced open-source intelligence gathering and analysis techniques that enable learners to extend their portfolio of analytic tools, improve situational awareness and take on more demanding investigative challenges.

Course modules include:

#### Enhanced Deep Web and Social Media Research

- Methods for investigating on auction and classified sites
- Enhanced research techniques for Canadian public records
- Techniques for conducting research on dating apps and websites
- Techniques for researching public records in the US and internationally

#### **Enhanced Data Collection and Analysis Techniques**

- Applications and techniques for scraping and exporting web content
- Introduction to analytics in open source
- Browser tools for deeper website analysis

#### Situational Awareness Through Open-Source

- Introduction to situational awareness through open-source information
- Monitoring of key resources and real-time events
- Fundraising applications
- Geospatial analysis

#### Additional Information

Each course takes approximately 25 to 35 hours to complete and culminates in a certificate of completion detailing the modules covered. All participants receive reference guides and a handbook, and government, regulatory and law enforcement clients get access to a community of practice that includes course materials, an OSINT toolbox and access to an online knowledge-sharing forum of fellow practitioners.
